

## **Bridgers Creek Hunting Lodge Liability Waiver**

All hunters, fishermen and guests must read, understand and agree to this waiver before beginning your agritourism experience, including hunting and/or fishing.

Under North Carolina law, there is no liability for an injury to or death of a participant in an agritourism activity conducted at this agritourism location if such injury or death results from the inherent risks of the agritourism activity. Inherent risks of agritourism activities include, among others, risks of injury inherent to land, equipment, and animals, as well as the potential for you to act in a negligent manner that may contribute to your injury or death. You are assuming the risk of participating in this agritourism activity. (NCGS 99E-32b)

It is the understanding and agreement that if any hunter, or guest should encounter an accident of any type to their body, including injury or death, customer agrees to notify Bridgers Creek Hunting Lodge immediately and will not hold Bridgers Creek Hunting Lodge responsible or held to be liable for any cost, repair, replacement to property or medical expenses for such accidents nor will Bridgers Creek Hunting Lodge, its proprietors, staff, landowners, guides or partners incur any liability claim or be held responsible for the actions of any hunter or guests.

Although Bridgers Creek Hunting Lodge has taken many safety measures to ensure a safe hunting experience and general visit to our property for all customers; all hunters, fishermen, parents or guardians of minors, and guests understand and agree that they will be taking part in all activities, including hunting and/or fishing, atBridgers Creek Hunting Lodge at their own risk. It is agreed and understood by all parties that Bridgers Creek Hunting Lodge will not be held liable or responsible for any accidents, encounters with dangerous animals, or acts of God including weather that may cause accidents, injury or death. Furthermore, customers agree to not cause harm to Bridgers Creek Hunting Lodge as an entity or to any of their property in any form or way. If damage or loss occurs to Bridgers Creek Hunting Lodge property, customer agrees to pay full replacement cost of any property owned by Bridgers Creek Hunting Lodge in the case where the customer causes such damage whether on purpose or by accident within 30 days of the damage to the property.

Bridgers Creek Hunting Lodge will maintain a basic first aid kit. In the event first aid or CPR is given to any customer, it is agreed and understood that Bridgers Creek Hunting Lodge will not be held at fault for any further injury caused by administering basic first aid and/or CPR where needed. Bridgers Creek Hunting Lodge protocol for any serious accidents is to call 911 for immediate medical and life saving treatment. Each hunter, fisherman, parent/guardian and guest must sign this waiver before or upon arrival at Bridgers Creek Hunting Lodge in order to continue the experience. Parents or Guardians are responsible for any minor children accompanying them including their behavior and actions. This waiver applies to minor children as well. This waiver has no expiration date and applies to each visit customer makes to Bridgers Creek Hunting Lodge.

## Understanding of services.

It is understood and agreed that Bridgers Creek Hunting Lodge does not guarantee the harvest of any game animal or the venture of sighting preferred animals. Fees paid for this experience, services, lodging and/or miscellaneous items are non-refundable.
